BASIC GUIDELINES AND REQUIREMENTS

1. To be eligible to participate in the Program, student must be a graduating senior who resides within the territorial limits of the Monticello Central School District.
2. To be given serious consideration by the Scholarship Committee, student must:
 - a. has maintained a grade point average of 3.2 or above;
 - b. is able to demonstrate financial need;
 - c. gives further evidence as to ability, commitment and personal initiative to achieving his/her goals.
 - d. has maintained a safe driving record during their high school years (proof required).

***4 DIFFERENT ESSAY QUESTIONS ROTATE ANNUALLY**

Essay for 2018, 2022, 2026, 2030 etc. - Create an essay telling us how you would change the world.

Essay for 2019, 2023, 2027, 2031, etc. - Compose an essay as if you were addressing the nation. Your theme/dissertation/focus is yours to create. Here is the criteria: How do you address the rising fatalities amongst teens and driving throughout our nation? What would be your project/mission/idea?

Essay for 2020, 2024, 2028, 2032, etc. - Create a speech...that you would read to your peers. This should be addressed to an actual audience at a "Not One More" forum. What do you know that adults don't?..... Speak the truth.

Essay for 2021, 2025, 2029, 2033 etc. - Sierra once told Ashley: "True friends are like stars, sometimes you can't see them but they are always there." Create an essay telling us what you think being a friend is all about.

To be considered, all parts of the application must be completed in accordance with the instructions given. Applications should be returned to the guidance office by April 15.

Be sure to read the application carefully before beginning to fill it out. Your school guidance counselors are prepared to explain the Scholarship Program to you, assist you in compiling your scholastic record and answer any questions you may have regarding the information requested.

If for any reason you are unable to provide a satisfactory answer to any question, state the reason or reasons on the back of the appropriate page. If you need more space to answer any question, you may also use the back of the page the question is on, and please label appropriately.

Please remember to obtain a copy of your driving record using the attached DMV Form "Request for Driving Record Information" and be sure to attach this information to your completed application. Also be sure to sign the application at the end of Part V.

The completed application is for the exclusive use of the Scholarship Committee. All information will be considered strictly confidential.
