The Community Foundation of Orange and Sullivan County is pleased to administer *The Earle and Elizabeth Wilde - Cornell Cooperative Extension Sullivan County Scholarship Fund*.

The Scholarship is open to graduating high school seniors from the Sullivan County area who plan to continue their education in an agricultural related field at either the State University of New York College of Agriculture and Technology at Cobleskill or Morrisville.

For your application to be considered, the following criteria must be met:

1. Candidate must be a resident of Sullivan County and a graduating high school senior attending a Sullivan County high school.
2. Preference will be given to a graduating senior whose family is actively engaged in agriculture.
3. Consideration will be given to the graduating senior who was engaged in FFA, 4-H or other youth program.
4. An essay of no less than 500 words is required of the applicant, stating financial need, goals, background, grades, extra-curricular activities and community service.
5. *Please include a letter of recommendation.*
6. Candidate will need to provide a copy of their tuition bill and payment will be made directly to the college / university if awarded.
7. Scholarships may only be used for undergraduate studies.
8. Completed application (see below).

SELECTIONS PROCESS:

1. Recommendations/selections will be made by a Selections Committee appointed by Cornell Cooperative Extension Sullivan County.
2. Family member(s) of the named fund (e.g. Fred Bach) will be informed of the committee screening for applicants and family member reserves the right to vote on the committee for scholarship recipients.
3. Final recommendations of Selections Committee will be presented to Community Foundation of Orange and Sullivan by no later than May 1 annually.
